**Codification of the General and Penal Ordinances
of the Town of Big Piney, Wyoming**

PREFACE

The Big Piney Municipal Code has been codified and indexed by Van Graham, Town Attorney for the Town of Big Piney, Wyoming. The general ordinances of the Town had been codified on two prior occasions, the latest recodification being adopted in 1972. This codification was completed in 1999, and initially included ordinances through and including Ordinance No. 98-23. As this Code was being compiled for delivery, the Town Council adopted two additional ordinances which are included as the first update of this Code. The Code will be kept current through regular updates.

The Code is organized and classified to follow the general codification scheme of Wyoming Statutes. It is organized in Titles, and under each Title it is organized into Chapters. Under each Chapter the specific Code provisions are codified as Sections. A citation to § 7-10-100 refers to Section 100 of Chapter 10 of Title 7. The Chapter numbers and Section numbers are organized to leave room for future expansion. Following each Section number is the ordinance history.

In the Tables part of the Code book, there are two tables. The first is a table of comparative sections which cross references the Section numbers in the 1972 Recodified Ordinances with the Section numbers in the 1999 Big Piney Municipal Code. Some special ordinances were in the 1972 recodification, such as annexations and franchises. These have not been codified in the Big Piney Municipal Code, and in the table of comparative sections are indicated by "NC" where the cross reference would otherwise appear. The second table is a list of all ordinances of the Town of Big Piney which have been located by the Town Clerk. There are some gaps in the ordinance history table because copies of ordinances could not be found. The gaps are covered, however, by the adoption of the subsequent codifications which set out the ordinances in full.
